Terms & Conditions

SECTION 1 – GRANT OF RIGHTS

Licensor grants to Licensee a non-exclusive, non-transferable license to physically display The Work at the Licensed Premises for the agreed term, in the contexts checked in the License Scope table above. Rights are limited strictly to physical, in-person display. No other use is permitted.

SECTION 2 – DIGITAL EXCLUSION

This license does not include, and expressly prohibits, any digital reproduction, display, or distribution of The Work in any form — including websites, social media, digital signage, email, screen-based display, or any other electronic medium. No digital files of any kind are supplied to Licensee.

SECTION 3 – PHYSICAL PRINT DELIVERY

Licensor will coordinate production of The Work at the agreed dimensions through an approved fine art laboratory and deliver a finished physical print. All scan files and original negatives remain the sole property of Licensor and will not be shared.

SECTION 4 – TERM & RENEWAL

The license begins on the Start Date and expires at the end of the agreed term. Licensee has first right of renewal at the original rate, exercisable no later than 60 days before expiration. Upon expiration, Licensee must cease all display of The Work and return or destroy the physical print.

SECTION 5 – COPYRIGHT & OWNERSHIP

All copyright and intellectual property in The Work remain exclusively with Licensor. This Agreement grants display rights only. Licensee acquires no ownership interest. Licensor may license The Work to other parties in non-competing contexts.

SECTION 6 – AI TRAINING PROHIBITION

Licensee shall not use The Work as training data for any artificial intelligence, machine learning, or generative model system. This prohibition survives termination.

SECTION 7 – PAYMENT

50% due upon execution; 50% due upon delivery of the physical print. All fees are non-refundable. Renewal fees are due 30 days before the new term commences.

SECTION 8 – GOVERNING LAW

Governed by California law. Disputes resolved by binding JAMS arbitration in San Francisco, CA. Prevailing party recovers reasonable attorney's fees.
